### MEASURING and HEIGHT CARD INFORMATION

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog **before** its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

### NEW Simplified Jump Height Card Process

When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog needs to be officially measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the *Dogs to Be Measured List*. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

### DOG ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of register able breeds that may participate. Puppies under four months of age are strictly prohibited from the trial grounds.

### OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. All classes will take place **outdoors undercover** on **dirt**. Ring size will be **100 x 100**.

**Illegible entries** will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a **\$25.00** collection fee to the amount of each returned check.

During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be as follows: Online Entries 200, Paper Entries 500, total for all trials. If either form of entry (paper or online) has not filled at the end of the 48-hour time period, the club reserves the right to decrease or increase either one accordingly. No hand deliveries will be accepted in the first twenty-four hours following the opening date and time.

**From the South:**

Traveling north on Interstate 25, take Exit 233 to Alameda Blvd. Take Alameda Blvd. west to Second Street. Turn right (north) on Second Street. Proceed approximately 0.8 mile to an unpaved road just past the Bernalillo County Sheriff's Posse sign. Turn right (east) and proceed approximately 0.2 mile to the arena.

**From the East:**

Traveling west on I-40, take the I-25 exit going north. Traveling north on I-25, take Exit 233 to Alameda Blvd. Take Alameda Blvd. west to Second Street. Turn right (north) on Second Street. Proceed approximately 0.8 mile to an unpaved road just past the Bernalillo County Sheriff's Posse sign. Turn right (east) and proceed approximately 0.2 mile to the arena.

**From the West:**

Traveling east on I-40, take the I-25 exit going north. Traveling north on I-25, take Exit 233 to Alameda Blvd. Take Alameda Blvd. west to Second Street. Turn right (north) on Second Street. Proceed approximately 0.8 mile to an unpaved road just past the Bernalillo County Sheriff's Posse sign. Turn right (east) and proceed approximately 0.2 mile to the arena.

### COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

## RIBBONS, AWARDS, AND PRIZES

Strip ribbons will be awarded in each jump height division in each class as follows:

First Place.....	Blue
Second Place.....	Red
Third Place.....	Yellow
Fourth Place.....	White
Qualifying Score.....	Dark Green

Strip ribbons will be awarded to the First through Fourth place teams in each jump height in STD, JWW & FAST classes; and, to First place teams in Time to Beat classes. Qualifying ribbons will be awarded to all dogs receiving qualifying scores. Rosettes will be awarded to New Titles earned at our trials. Dogs completing the PAX title at these trials will be awarded a Rosette. A Rosette and Jump Bar will be presented to newly titled MACH, PACH and AGCH dogs.

## NOTICE TO EXHIBITORS

All exhibitors should obtain a copy of the Regulations for Agility Trials by downloading them from the American Kennel Club website at <http://www.akc.org/rules/>.

### SAFETY, BEHAVIOR and LIABILITY

**The safety of the dog** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

**It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The **Valencia Valley Kennel Club** and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The **Valencia Valley Kennel Club** reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the **Valencia Valley Kennel Club** or any official thereof.

**All dogs must be on leash** at all times when on trial grounds except when in the designated warm-up area or competing on the course.

**REFUNDS No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. A withdrawal from the trial after the closing date due to an injury and/or illness to the dog will be eligible for a refund up to 75% of the total entry fee paid. A veterinarian's notice of injury or illness will be required for the refund to be issued. Bitches in season are not permitted to compete in Agility Trials. As such, the club will refund 100% per day of the entry fee paid for bitches unable to compete for this reason. In order to receive a refund the handler must notify the Trial Secretary prior to the start of judging on the first day of the trial or cluster of trials.**

**Dogs may arrive** any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

**Judges are not required** to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public-address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**CATALOGS:** A limited number of catalogs will be available for viewing at the trial secretary booth. None will be sold. Running order sheets will be available at no charge and posted online after closing with one copy posted at the trial site during the trials.

## ADDITIONAL SITE INFORMATION

Both Rings will be enclosed by pipe Fencing and netting. All contact equipment and tables will have a rubberized surface.

**DOGS ARE NOT ALLOWED IN THE RESTROOMS OR ON THE GRASS AREA IN FRONT OF THE POSSE CLUBHOUSE.** Any exhibitor failing to comply may be excused from the trial without any refund if the Trial Committee deems the exhibitor to be in violation of this requirement.

**This test will be held in a livestock facility.** It is possible that there could be livestock in pens adjacent to the rings and crating areas. If your dog is not under reasonable control around livestock, you may not wish to attend this event. Rings will be surrounded by a lightweight netting..

There is ample parking in the large gravel/dirt lot surround the arena. Please do not park or set up crates in the fire zone. No parking spaces may be saved overnight.

**RV Parking:** Self-contained RV parking is permitted at the site at no charge. Electrical and water hookups are available at \$25/night. Contact the Sheriff's Posse Representative upon arrival or sometime during your stay. All vehicles with generators turned on must be parked at least 50 feet from the arena during show hours. No dumping of holding tanks, grey water, or sewage on the trial grounds or parking lot is permitted.

**No overnight security will be provided.** The grounds are fenced and there will likely be RV's parked overnight, but there will be no hired overnight security at this trial site.

**Crating space** is available on the north side of the arena and under the bleachers on the south side. Please do not set up crates in the fire zone or up in the bleachers. You may bring shade tents for shade, but be aware that the ground surrounds the arena is very hard and wind is often an issue in Albuquerque. Crates and tents may be left overnight, but the Valencia Valley Kennel Club and the AKC will not be responsible for any lost or damaged items left at the show site.

**Seating space is ample at this site.** There are bleachers on the south side of the arena. Please stay clear of the ring entrances and exits and the practice jumps. Due to safety and space concerns, no exhibitor chairs will be allowed between the rings. Exhibitors and handlers will be held responsible for clean conditions in and around their crating and parking areas. No dogs are allowed to be left unattended at the site overnight.

AGREEMENT

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend, and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTREPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partners<sup>SM</sup> program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
